

Winter War 38 Judges Submission Form

The Winter War Gaming Convention is seeking judges to organize and run games at its 38th annual Winter War Gaming Convention, January 28 – 30, 2011, held at the Hawthorn Suites in Champaign, IL. Judges who run a single event receive a 50% discount on weekend registration or free registration for a single day. Judges who run two or more events receive free weekend registration. Judges must pay for events they play in.

This form is NOT a registration form; submitting an event for Winter War does NOT register you for the convention. If you do not pre-register for Winter War 38, you will need to register at the convention.
